

**USA HOCKEY
PACIFIC DISTRICT
ANNUAL MEETING – OPEN SESSION
January 30, 2010**

The Annual Meeting for the Pacific District of USA Hockey was held on Saturday the 30th day of January 2010, at The Silver Legacy Hotel in Reno, Nevada.

Chairman Bruce Urban called the meeting to order at 9:01 pm.

The following persons were present: Dick Coombs, Charlie Fuertsch, Dru Hammond, Donna Kaufman, Steve Laing, Natalie McEwen, Kevin McNaughton, Dan Rogness, Mike Sullivan, Bruce Urban, and Cullen Wallace.

The following guests were present at the meeting: Lynn Beehler-Urban – Director at Large, Margo Dreyer – Girls’/Women’s, Steve Stevens – Referee-in-Chief, Casey Jorgensen – In-line Section Director, and Connie Hardwick – Alaska Associate Registrar.

The chair asked for changes to the agenda.

Motion was made by Cullen Wallace, seconded by Charlie Fuertsch, and unanimously approved to amend the agenda with additional items.

Minutes:

Motion was made by Steve Laing, seconded by Charlie Fuertsch, and unanimously approved the minutes from the Seattle meeting of October 24, 2009, as amended.

Treasurers Report:

Charlie Fuertsch thoroughly reviewed the District’s financial report that he emailed to all parties prior to the meeting. He reviewed the balance sheet, profit & loss statement, bank account reconciliation, block grant reconciliation, boy’s development camp, girl’s development camp, and 2010 district playoff fees.

Charlie advised the Federal tax return was due on January 15th. He submitted on January 13th. Our list of financial officers is due in February. Charlie will insure to provide this list and pay the appropriate fee. We are registered in the State of Nevada.

Motion was made by Cullen Wallace, seconded by Mike Sullivan and unanimously approved the treasurer’s report.

Registrar’s Report:

Dan gave a recap on the current registration within the district; we are currently at 91% of totals from last year. The district has picked up a few percent since the meeting in Orlando.

Dan's general feeling is we will be very close to last year's registration. Cullen Wallace asked when the final numbers are set for cut off. It is August 31. There is some overlap, as registration can begin in May. However, you need to choose a box as to what year the registration pertains.

Dan advised he has sent the election notice, for District Director position, to all the association registrars. He has a list of all the association registrars with their names and email address. He has made a copy for both Cullen and Casey. Dan also asked how we're going to handle junior teams from a voting perspective. There was general discussion among the board. Dan will look into this issue prior to the ballots being sent out. Dan will send out the ballots on April 1st.

Charlie noted that Dru Hammond is willing to post the election notice on the District website. As well, she could post a bio for both Casey and Cullen. It was agreed to post a notice of election on the website.

By-Law Change:

Bruce Urban brought up the discussion on the Chair for the Board of Directors as announced in the prior meeting. The current by-law language was read.

Motion was made by Bruce Urban, seconded by Steve Laing that "Annually, the Board of Directors, by majority vote, shall select which USA Hockey Director duly elected within the Pacific District shall be Chair of the Board or, in his or her absence, any Director selected by the Chair of the Board shall preside at meetings of the Board of Directors."

A friendly amendment motion was offered by Charlie Fuertsch, seconded by Dick Coombs, agreed to by Bruce Urban and Steve Laing, and unanimously approved that "At the annual meeting or such time a vacancy occurs, the Board of Directors, by majority vote, shall select which USA Hockey Director duly elected within the Pacific District shall be Chair of the Board or, in his or her absence, any Director selected by the Chair of the Board shall preside at meetings of the Board of Directors."

Motion was made by Dick Coombs, seconded by Dru Hammond to amend the previous motion and unanimously approved that “*At the annual meeting or such time a vacancy occurs, the Board of Directors, by majority vote, shall select which USA Hockey Director duly elected within the Pacific District shall be Chair of the Board or, in his or her absence, any Director selected by the Chair of the Board shall preside at meetings of the Board of Directors commencing with the next meeting.*”

Charlie Fuertsch commented on a couple of other changes to the by-laws. These notices need to be presented to the board in May, so they can be voted on in October. Charlie will send out wording to the board. Generally he was looking at cleaning up the actual dates of regular meetings. The board also discussed the location of these meetings as addressed in the bylaws.

Charlie also discussed the by-laws require a member’s (the five affiliate presidents) meeting. They are supposed to meet twice a year. Charlie announced they have elected Steve Laing as the Chair of the Meeting. There was discussion as to the true need for this members meeting.

Motion was made by Cullen Wallace, seconded by Mike Sullivan and unanimously approved the establishment of a by-law committee of Charlie Fuertsch, Dick Coombs and Dru Hammond.

This committee will provide information for the May meeting. Voting could then take place at the October meeting. There is a need to insure the guidebook and by-laws are in alignment.

Dick Coombs will send a currently copy of the by-laws electronically to everyone.

Multi-District Meeting

Charlie Fuertsch gave a recap of the multi-district meeting in Orlando. There were a number of subjects addressed. These meetings are not voting meetings. They’re simply meeting to discuss common interest.

Cross-Ice – Districts were to review with their affiliates and understand who is participating in cross-ice programs. There was an array of answers. There was also discussion if USA Hockey should mandate mite cross-ice. Our board had discussion amongst themselves on the subject.

ADM mandate and enforcement – unless USAH mandates, programs may not follow. Now USA Hockey’s focus is at the mite level.

High School / Federation play – There was conversation trying to understand if USA Hockey high school teams are playing federation teams.

USA Hockey Governance – There was discussion to understand the direction of the new governance proposal. Casey shared his general belief as to its direction to our board.

The multi-district members agreed to meet again in June at the Annual Congress. Our board members thought this is a productive format and feel we should continue participation.

Tournaments:

Donna Kaufman presented a proposed tournament structure to the board. The seedings were reviewed for each division as well as schedules layouts.

Motion was made by Dru Hammond, seconded by Dick Coombs and unanimously approved the proposed tournament seeding and schedules as amended during discussion for Youth and Girls teams. (see attached)

Motion was made by Dru Hammond, seconded by Natalie McEwen and unanimously approved the proposed tournament seeding and schedules as amended during discussion for women's teams. (see attached)

Donna Kaufman advised the tournaments would be published on web. Dru Hammond will add a link to the district site.

It was also discussed the basic procedure for credentials. Teams will be required to have their verification sheet sent to Dan Rogness. The teams will need to make sure they have their credentials book with them. Donna Kaufman will be the tournament chair with Dan Rogness as the main Registrar. A schedule will be made for the directors to cover all tournament games.

Tier II Affiliate Champions

Bruce Urban reviewed the affiliates Tier II championship schedules. These have been forwarded on to the National office. Bruce will have the National booklets (packages) sent to the presidents of each affiliate. They should be sent out by March 1st. It is imperative these booklets are given to the teams advancing on to Nationals.

2011 Girls Nationals

Mike Sullivan announced the 2011 Girl's Nationals were awarded to Nevada. Originally Nevada was told the tournament would only be a 36-team tournament. The 2010 tournament currently has 48 teams. Nevada will have only three rinks available and couldn't host a tournament of this size. They will not have the advantage of the Orleans rink on this particular weekend. Mike Sullivan plans to go back to the National office and rescind their bid based on the size of the tournament. Prior to formally advising the National office, Steve Laing will see if there is an opportunity to host this tournament in California. This would be presented as an option when advising the National office Nevada will rescind their bid.

Web Site:

Dru Hammond has done a nice job of reviving the district web site. Charlie Fuertsch would like to see each person on the board be responsible for a section of the site. This would help keep it fresh. Hopefully the affiliates can send Dru a short note of upcoming events or activities. She will post to the district site. As a reminder, the site URL is: www.pacificdistricthockey.com

Legislative Updates:

Bruce Urban wants everyone to get feed back from their affiliates on the elimination of 12U youth and girls National tournaments. It appears it will be on the June Annual Congress agenda. Both the youth council and girls'/women's sections appear to be in favor of eliminating the 12U tournaments. This is meant to be in alignment with the ADM program. There was a fair amount of discussion among the board on the subject.

Dick Coombs also reminded everyone there's General Proposal # 2 – the executive committee could change rules and regulations in between annual meetings. This proposal has been amended to still require board approval. This proposal will still need to be ratified at the annual meeting.

Block Grants:

Dick Coombs reviewed the block grant requests from around the District. These are similar to previous years. They are from the officiating, coaching, girls'/women's, and disabled programs. There were discussions about the amounts requested by the different programs.

The affiliate presidents understood they were to return 20% of their affiliate money toward the district block grants. In actuality they have been contributing 30%. They voted to provide 25% as they move forward. This would equate to \$9,003 this year.

The presidents agreed to the following allocations for a total of \$9,000 based on a 25% contribution.

- Disabled - \$1,000
- G/W - \$1,000
- Coaching - \$4,000
- Officials - \$3,000

Steve Laing made a presentation for the participation in the Multi-District Select Camp at Kent State University. The Mid-AM district is hosting this camp. Steve asked about where some of the funds would come from should we elect to participate in the multi-district camps. Could some of the block grant funds be utilized to support this program? Steve Laing presented a potential budget for a team. There will be two events, one for 14 and one for 15 year olds. There would be six teams for each event. Based on this proposal, the committee's recommendation is to approve participation in the multi-district event.

Motion was made by Donna Kaufman, seconded by Cullen Wallace and unanimously approved the Multi-District Select Camp Program for the Pacific District. Steve Laing offered a friendly amendment to remove staff airfare from the proposal for a new total of \$6,500 for a per player fee of \$325. (plus airfare). This motion was unanimously approved

With the passing of this proposal, the affiliate President's have agreed to increase their block grant contributions to 30% at \$10,803.90 toward the district funds. This will contribute a line item of \$1,800 toward staff travel toward the multi-district camp event.

Motion was made by Dru Hammond, seconded by Mike Sullivan and unanimously approved the funding of the District Block grants as proposed.

Motion was made by Charlie Fuertsch, seconded by Donna Kaufman and unanimously approved that \$1,800 will be allocated from block grant contingency funds for the multi-district event.

Steve Laing, Charlie Fuertsch, and Dru Hammond will continue to work the logistics and present to the board at the May meeting.

Boy's Player Development - Selects:

Bruce Urban gave an update on the boy's select camp. He has already made most of the travel reservations. He has also visited with the hotel. The hotel is under new management and has reserved the hotel accordingly.

Bruce also discussed a new registration program the national camp is using for player development. He would like the district to look into its use. If an affiliate is using the same

program, the data can automatically be moved from the affiliate to the district. A player is contacted by email. It will be VERY important to gather the player's correct email address. They can go online to register and pay. This would help stream line the registration process. The program is from Rocky Mountain Register. It has been highly recommended by the National office to use this program. The cost is \$3.00 per registration and 3% of total revenue collected.

Motion was made by Charlie Fuertsch, seconded by Cullen Wallace and unanimously approved to use the Rocky Mountain Register program for this year's district select camps.

Bruce shared the Pacific District has done an outstanding job of sending players on to the National camps. We only had a few "C" level evaluations between all our boy and girls players.

Bruce also shared the dates on the National camps for this summer. He has asked Dru Hammond to post this information on the district website.

Charlie asked if anyone is working with Bruce to learn and understand the process of the development camp. Bruce is willing to work with anyone to explain the running of the camp. To date, no other board member has really worked directly with Bruce as to the "complete running" of the camp. Cullen suggested we wait until the election of a new district director and determine the future director responsibilities.

Female Player Development:

Margo Dryer shared with the board that the girls' section discussed the goalie selection process. She read a letter, from Michelle Amadon, stating a goalie evaluation form can be completed and submitted as a recommendation, but the program will ultimately make the selection. They still have not addressed the selection process.

Margo contacted the player evaluator recommendations from California. She has spoken with three of the four. They are willing to participate at this year's camp. Margo plans on using them. She also shared the request from PHAHA and plans to use their recommendations. Margo has secured rates with the buses, rinks, and hotels. Everything appears to be going smoothly at this point in time.

Referee Program:

Steve Stevens has traveled to the Nor Cal meeting a few weeks ago. He has appointed Randy Meyer for this area. He has also visited Oregon last weekend. They plan to make a change for the Oregon RIC in the near future. It appears we have six or seven referees selected to National tournaments this year. Normally we only get three.

Steve has all the tournament numbers and will start scheduling referees. There are also state tournaments taking place this same weekend in southern California. Winners from both tournaments will move to Nationals. Steve has also appointed an evaluator in the Nevada area.

Coaching Program:

Larry's report

Alaska has tentatively replaced Blasé Burkhart with Rick Trupp. They are currently in a transition period.

Screening:

Charlie Fuertsch announced the national screen process is essential dead. USA Hockey is not planning to mandate this program. Three particular districts are adamant they will not participate in the proposed program.

Bob Freeland Grant Program

Charlie expressed a concern about weather the program is accomplishing its goal. Responses have been minimal from the current participants. We want insure we are achieving its goal and the proper recognition of Bob's name and legacy.

Maybe the board needs to review the process in awarding the grant. Bruce believes the affiliate presidents could help to insure the programs, receiving grants, in their affiliate are working and helping grow hockey. Bruce will also provide an update on the responses he has received to date.

Cullen reminded the board the goal of the program was to help keep Bob's name and memory alive. Cullen also believes this should apply to the Andy, Dempy, and Pete Anderson Awards. We need to look into adding a bio to the website and potentially the guidebook.

Selection of new Chairperson

Motion was made by Charlie Fuertsch, seconded by Dick Coombs and unanimously approved to select Donna Kaufman be the new Chairperson effective May 15, 2010.

Future Meetings:

The next Board of Directors meeting will be May 15 in Seattle, Washington. Dan Rogness shall advise us of the hotel arrangements. It will be at the Double Tree Suites.

Pacific District CIC Report

The 2009 CEP clinic season surprisingly had a slightly higher number of attendees than the previous year. Even with our Level IV attendance down, the levels I, II and III increased enough to create a positive number relative to 2008. Following are the clinic totals for the Pacific District:

- 16 Level I Clinics – total of 445 coaches
- 15 Level II Clinics – total of 376 coaches
- 15 Level III Clinics – total of 360 coaches
- 1 Level IV Clinic – total of 65 coaches

We held our annual CEP instructors meeting during the Level IV seminar and many issues were discussed including the implementation of the ADM Program as it relates to the coaching education program.

We were successful in listing all of our coaching clinics on line and as a result, 98% of all coaching program clinic participants registered in advance on line. The District had a record number of temporary card requests in '09 for some reason, with most of them coming right at the end of the year.

The new ADM will be affecting the certification process and the various levels each coach will have to achieve in order to coach certain levels of hockey.
