Chair Donna Kaufman called the meeting to order at 9:00 a.m. and welcomed everyone.

Lisa McPheters will be recording the minutes and everyone is encouraged to speak loudly and clearly for adequate recording.

# **Approval of Old Minutes**

Kris Knauss motioned to approve the minutes from October 3, 2015; Dru Hammond seconded the motion. Motion passed with no opposition.

Darryl Thompson motioned to approve the minutes from January 19, 2016 teleconference; Steve Laing seconded the motion. Motion passed with no opposition.

### **District Financial Report – Chris Hays**

Chris provided a thorough verbal review of the district numbers as well as a written report. The proposed district budget was not approved at the October 3, 2015 board meeting due to Chris Hays absence. Gordon Brown motioned to approve the proposed district budget; Greg Yochum seconded the motion. Motion passed with no opposition.

# **Bobby Freeland Grant - Natalie McEwen**

- Palmer Amateur Hockey Association applied for a \$2,500 Bobby Freeland Grant. Darryl Thompson motioned to approve the grant; Greg Yochum seconded the motion. Motion passed with no opposition.
- Western Washington Female Association applied for a \$2,500 grant. Kellie Hays motioned to approve; Gordon Brown seconded the motion. Motion passed with no opposition.
- Darryl Thompson to locate and forward to the board the grant application from Challenge Alaska Sled Hockey.

### **Disabled Hockey – Kellie Hays**

Written report is attached, but two highlights.

- A new classification proposed Warrior Hockey. Proposed eligibility requirement for this classification is attached in the written report please pass this on in your affiliate and provide feedback to Kellie prior to the June 2016 USA Hockey Annual Congress.
- 100 mile rule change for sled hockey. Also attached to the written report. Please distribute to sled groups in your affiliate and provide Kellie with feedback prior to June 2016 USA Hockey Annual Congress.

Sunday Sled Hockey Clinic. 15 athletes currently registered, with 8 volunteers besides the Pacific District Board. There may also be up to a dozen athletes and coaches from the Ice Palace.

USA Paralympic Gold Medalists – Taylor Lipsett & Andy Yohe – will be joining us for this event.

Kellie discussed working with athletes with disabilities. How to approach and talk to them using "person centered language". "What is your diagnosis?" They have skills, abilities, and characteristics. No one is referred to as retarded, crippled or handicapped. Very informative, well-delivered presentation.

# Coaching Program – Larry Bruyere & Rick Trupp

- Rick Trupp communicated that he had nothing to report.
- CIC Selection Process Kris Knauss
   Kris Knauss is the point person for the Pacific District's CIC selection process. Currently posted on Pacific District website as an open position. Deadline to apply is March 15, 2016. Pacific District Board will make a recommendation to USA Hockey's Executive Committee and Executive Director of at least 3 candidates, by the district's May, 2016 board meeting. To date, one person has applied. Larry Bruyere has recommended Jeff Bruckmen, Rob Foster and Flint Doungehak.

## Female Hockey - Greg Johnson

Report submitted electronically, copy attached.

Kris Knauss raised the discussion that in 2015 our district was in the red from the Girls Multi-District Camp. Why? Do we have a budget for the 2016 camp so we can avoid being in the red in the future? The Pacific District likely needs more structure in the administrative aspect of the Girls Multi-District Camp. We not only need to know where the money is being spent, but be part of the decision making process. Having a member of the Pacific District Board take on an integral role in the Girls Multi-District camp is desirable.

# Referee Program

- Eric Simmons, Alaska RIC, submitted a written report, copy attached.
- Steve Stevens, Pacific District RIC, submitted a written report, copy attached.

Would like the two RIC's to get together and come up with some plans for developing and increasing the numbers of referees. Our district is growing in player numbers, so we need to have referee numbers increase in correlation with this. Kris Knauss motioned that all affiliate RIC's (or their representative), along with the District RIC's meet on Friday night prior to the May 2016 Pacific District Board Meeting to have a "summit workshop" on the development of referees; Darryl Thompson seconded the motion. Motion passed with no opposition.

# Registrar's Report - Wendy Goldstein.

Written report attached. USA Hockey shows our district ahead of where we were at this time last year. Girls registration numbers were included for Girls Tier 1 Hockey discussion and determination.

Wendy will electronically send notification of the District Director election out next week. Steve Laing and Dru Hammond are running for Director. Associations have to claim personnel by March 15<sup>th</sup> to count towards the voting numbers. Associations have one month to vote, April 1 to May 1, 2016.

### Safe Sport Report - Steve Laing

Written report attached.

Discussion on concerns of people filing erroneous Safe Sport claims was held. These type of claims are an issue that the affiliates and district will keep an eye on over the season and into the future.

#### Tournaments - Donna Kaufman

District Tournament schedules are being finalized now, as teams qualify. We are very fortunate to have two great locations hosting tournaments, Anchorage, Alaska for Girls Districts and El Segundo, California for Youth Districts.

National Tournaments – all affiliates should notified the national office on spots to be reserved for Tier II teams. National office is looking at scaling back the Tier II national tournaments. 14U Tier I Nationals in Alaska – have 12 districts sending a team along with a host team, so that leaves 3 at-large bids instead of 4.

Add to May's district board meeting a discussion on when teams need to declare their Tier level.

National High School Tournaments. Steve Laing stated that USA Hockey is looking at reducing the numbers for the high school tournaments as well. Try to get back to single affiliate teams participating.

2017 Disabled Festival is April 6-9, 2017 in California. Please clear your calendars to be able to help at this event.

# Player Development – Kris Knauss

Boys Player Development Camp. All affiliate camps are complete. May 5-8, 2016 for 15, 16 & 17
 District Player Development Camp in San Jose. Have good involvement from the affiliates for team
 leaders. Changed the hotel venue this year to the San Jose Hilton. This year we are bringing in more
 college coach evaluators from the east coast.

- Girls District Player Development Camp. Discussed above under Female hockey. Have some concerns that we are working on.
- USA Hockey has added an ADM Goaltender Coordinator to help with goalie development.
- USA Hockey working with Finland. Finland just won world juniors, yet are the size of the state of Massachusetts. Our ADM can learn from them and what they are doing to be so successful. Make our best practices our strongest practices.
- 10U Cross/Half Ice? ADM wants to move in that direction. Encourage affiliates to move in that direction.

# **USA Hockey Discussion - Legislative Proposals**

Do we as the Pacific District Board support the Tier 1 Open and Tier 1 divisions that are being proposed by USA Hockey?

Tier 1 Open – Possible New Division in USA Hockey (legislative proposal 4)

- Recognized at only 14U, 15, 16U & 18U levels.
- Must have 12 on ice practices and 8 off ice practices per month.
- Program must have been in existence for 3 previous years.
- Requires a feeder program within your association, affiliate.
- Can have players from other affiliates, areas across the country. No restrictions.

Tier 1 Hockey (existing division) (legislative proposal 3)

- Can't advertise until 48 hours after the national tournament.
- Program must have been in existence for 3 previous years.
- For an affiliate to be eligible to have a Tier 1 team, as of September 1<sup>st</sup>, an affiliate takes 15% of its' players at an age level, based on 20 players per team, and that determines the number of Tier 1 teams an affiliate can have.
- Minimum of 15 players on a team.

After much discussion about all the criteria to be a Tier 1 Open program, and the differences between Tier 1 Open and Tier 1, the board determined they were in support of both Tier 1 Open and Tier 1as presently defined in the legislative proposals. Tier 1 Open may be hard for affiliates to accept to begin with, but as time goes by, it gets Tier 1 hockey where USA Hockey would like it to be with affiliates having clear development programs. Development should be the focus for affiliates.

15 Tier 1 National Championships – discussed support of this championship.

Tier 1 Girls Hockey (legislative proposal)

- Can't advertise until 48 hours after the national tournament.
- Program must have been in existence for 3 previous years.
- For an affiliate to be eligible to have a Tier 1 team, as of September 1<sup>st</sup>, an affiliate takes 20% of its' players at an age level, based on 18 players per team, and that determines the number of Tier 1 teams an affiliate can have.
- Minimum of 15 players on a team.

#### **Old Business**

 Donna Kaufman stated Greg Johnson and Bridget Hopkinson need to establish a Guidebook Definition for the Associate Girls/Women Rep position to be placed in the Pacific District Guidebook.

- Kris Knauss stated that the new district website is up and available to the public. He asked that everyone on the board take the time to look at the website and provide feedback to what they like and what needs to be changed or added. He requested that all directors provide a bio to be placed on the website.
- Approved Board Meeting Minutes will be placed on website.
- Challenge Alaska Bobby Freeland \$2,500 Grant. Darryl sent to the board his original request on this. Darryl Thompson motioned for approval of this grant; Kris Knauss seconded the motion. Motion passed with no opposition. Dru Hammond abstained.

#### New Business -

*Election Process* – Wendy Goldstein asked Rae Brigge and Casey Jorgenson for a determination on unclaimed personnel in the USA Hockey database. If unclaimed, are you considered a participant and therefore, does an affiliate president get to vote the unclaimed vote?

Affiliate President's Report – Steve Laing

- \$13,711 to the District for block grant money. Steve Laing motioned to earmark \$4,000 of these funds for district personnel travel expense to the 2017 Disabled Festival in California; Darryl Thompson seconded the motion. Motion passed with no opposition.

- Steve Laing retired as the Affiliate President Chairperson; Darryl Thompson has been elected as the new Affiliate President Chairperson.

Election of Pacific District Chairperson – Dru Hammond

Dru called for nominations for Pacific District Chairperson. Darryl Thompson moved that Donna Kaufman remain as Pacific District Chairperson; Greg Yochum seconded the motion. With no other nominations, it was declared by acclamation for Donna Kaufman to remain as Pacific District Chairperson.

We need better clarification for our players so they don't participate with a junior team and become ineligible to continue playing with their youth team.
- Gordon Brown PNAHA has had good progress with Joe Bonnett, their ADM director, this year.
  Hope it continues to translate across the state. Currently advertising for a Disabled
  Representative for PNAHA. Would like to see the board have meetings in other locations then
  Seattle.
- Donna Kaufman thanked everyone for being tremendous volunteers for their affiliates and the Pacific District.

Kris Knauss motioned to adjourn the meeting; Gordon Brown seconded. Motion passed with no opposition.
